We will only provide SMSF specific advice if sufficient details have been provided. We may decline to provide specific advice. The decision to decline does not have formal review rights.

We can provide specific advice about the following topics:

- investment rules including
  - an investment by an SMSF in a company or trust
  - acquisition of assets from related parties
  - borrowing and charges
  - in-house assets
  - business real property
- in specie contributions/payments
- payment of benefits under a condition of release.

We cannot provide financial advice. We will not provide specific advice if the request relates to:

- the complying status of your SMSF
- trustee covenants
- the residency status of your SMSF however, you can apply for a private ruling as this is a tax issue.
